## ARTICLE F

### RESTATEMENT OF ARTICLES

The Corporation hereby restates the provisions of its Articles of Incorporation as follows:

1. The name of this corporation shall be the Indiana Astronomical Society, Inc.
2. The purpose or purposes for which it is formed are exclusively for charitable, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
3. The period during which it is to continue as a corporation is perpetual.
4. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, directors, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in paragraph 2 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE F

5. Upon the dissolution of the Indiana Astronomical Society, Inc., the assets of the Society shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code or shall be distributed to the Children's Museum of Indianapolis, Indiana. Any such assets not so disposed of shall be distributed to the State of Indiana or the city of Indianapolis, Indiana for a public purpose.
